

This annual event is the premier showcase of contemporary artwork by promising local talent. With a different open-ended theme each year, artists are encouraged to pursue a broad range of artistic expression across media.

Unlike many open calls that charge a submission fee, Southern Exposure's juried exhibition and screening is entry-fee free. *Crank* features 49 Northern California artists living north of King City and south of Red Bluff. For many of the artists selected, this is their first major exhibition and a vital step forward in their art careers.

Over the course of two days, nearly 300 Northern Californian artists brought their artwork and proposals for installation, performance, social practice, site-specific and web-based work to Southern Exposure. Exhibition juror Lorelei

ABOUT THE JURORS

Lorelei Stewart, Director of Chicago's Gallery 400 since 2000, has organized over 40 exhibitions, including the Joyce Award-winning exhibition *Edgar Arceneaux: The Alchemy of Comedy...Stupid* (2006). In 2002, she initiated the acclaimed *At the Edge: Innovative Art in Chicago* series, a commissioning program that encouraged experimental practices by Chicago area artists. From 1994 to 1998 Stewart was Program Director at New Langton Arts, San Francisco. She holds a BA from Smith College, a BFA from Corcoran College of Art and Design, and an MA in Curatorial Studies from the Center for Curatorial Studies at Bard College.

Gabriela Monroy is a Mexican video artist and curator working between Helsinki, Mexico City and Berlin. From 2005 through 2013 she was co-director of video_dumbo, an international moving image festival in New York, with German video artist Caspar Stracke. In 2014 they were selected as the programmers for the 60th Flaherty Film Seminar, NY. Gabriela also received a NYFA Fellowship in Digital and Electronic Arts (2011) and was a juror for Transitio – International Festival for Electronic Arts and Video. She has participated in exhibitions in Mexico, Europe, Korea and the US, and her work is part of the INBA's collection, Mexico's National Institute for Fine Arts.
